



**Instructions for Completing the Application and Return for  
Agricultural Classification of Lands (DR-482)**  
*Application must be made by March 1<sup>st</sup>*

1. The property owner(s) name and mailing address.
2. Applicant's phone number(s) where they can be reached.
3. The 17 character Parcel Identification Number, or STRAP, for the property. For example, 11-47-25-00-00000.0000
4. Legal description of the property.
5. Type of agricultural classification and the size of the parcel that is being applied for, and the number of years the land has been used for this purpose. If your commodity is not listed, specify under "Other".
6. Income and Expense information for the operation.
7. Date the property was purchased.
8. The amount paid for the property.
9. If equipment or machinery is being used for the agricultural (greenbelt) operation, has a Tangible Personal Property Tax Return been filed? If not, a Tangible Personal Property Tax Return (DR-405) needs to be filed.\*
10. Is the property leased to someone else? If so, attach a copy of the lease with the application.
11. Has the property been rezoned to a non-agricultural use?
12. Year the application is being filed for.
13. Signature of the person(s) filing the application.
14. Filing date of the application.
